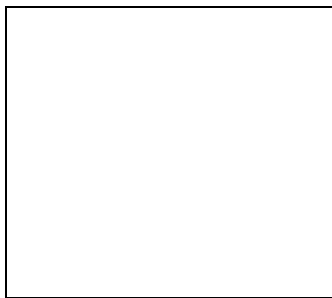

**IMPORTANT INFORMATION:**

Please note that changes were made to the NCC Constitution at the Annual Conference 2016 which required that "persons nominating for election to the Executive must be a member of a Member Body of the NCC and their nomination endorsed by an Office Holder of that member body, confirming their membership status".

In 2017, the Nomination form has been amended to require this information be provided.

**\*\*While not required nominees to the Executive are encouraged to provide this completed form by 1 October 2017 to [outreach@nature.org.au](mailto:outreach@nature.org.au) for it to be included in the papers disseminated to delegates before the conference.\*\***

The number of persons elected to the Executive shall be twelve (12). All endorsed members of member groups are eligible to stand for election.

Nominations for the election of Executive Members must be lodged by submitting this completed form to the Chairperson or their delegate, **by no later than 2pm on Saturday 28th October 2017** and seconded by two voting delegates.

If an election is required, nominated candidates may also speak to the Conference for up to three minutes prior to the election, in support of their candidacy. This is likely to occur on Sunday 29<sup>th</sup> October. The Executive usually meets on the **3rd Monday** of each month, except January, from approximately 5.30pm to 8pm. Members are expected to attend regularly. Teleconference facilities are available for regional members not able to attend meetings in Sydney.
